- 5. Cash Deals transactions are subject to Bank approval. Release of Cash Deals proceeds shall be as follows:

a. If via EqB Branch – cash will be released immediately upon complete verification of documents and approval of Cash Deals transaction.

b. If via Equicom 24/7 Customer Service – proceeds will be deposited directly to the Cardholder's Current or Savings account with EqB or with another bank as indicated on the application form within five (5) banking days from receipt of the Cash Deals application and required documents.
